This module focuses upon teaching excellence, learning and effective assessment through the continued development of the participant's own professional practice. Engagement in reflective evaluation enables participants to draw together findings gathered throughout this module forming an overall picture of their practice and underpinning this with evidence, research and relevant literature.
